#### OTHER SPECIAL FUNDS

The Mississippi Land, Water and Timber Resources has funded MIFI for the four of the last six years. In 2006 the amount was \$175,000, in 2007 the amount was reduced to \$75,000 to complete the regional forest inventory of the state. We do not anticipate asking for money in the 2008 FY because of money earned through grants from the EFCRP government programs for Hurricane Katrina relief. MIFI has requested \$75,000 additional funding in 2009 from MS Land Water and Timber funds.

The contract with MSU has expired as of June 2009 with no more funding or contracting sources at this time. MIFI has recieved quarterly funds from MSU since the agency's inception in 2003. The funds were granted by the US Forest Service's Wood Utilization Resources grant that were discontinued in 2007. These funds were made available to several universities across the nation for timber resource research.

MIFI provided assistance with the Katrina recovery plans for the MS Forestry Commission and Farm Services Agency of the Federal government. These funds were earned though contracts/MOU's with the MS Forestry Commission. They are one time funds and will not be a part of the continuing efforts of the agency. Since MIFI is now under the MFC, MFC has offered to pay for 1/2 of the salary of the Executive Director. The Executive Director also has responsibilities in the MFC.
