I. Program Description:

Section 55-5-51, Mississippi Code of 1972 established the Mississippi River Parkway Commission. The Commission is composed of ten members who are residents of the Mississippi River Counties. The Chairman of the Commission represents the State of Mississippi on the national Mississippi River Parkway Commission.

II. Program Objective:

The Mississippi River Parkway Commission exists to preserve, promote and enhance the scenic, historic, cultural, natural and recreational resources along the Mississippi River's Great River Road in efforts to foster economic growth and development in the Mississippi River Corridor. The State of Mississippi's Great River Road runs from the Mississippi - Tennessee State Line to the Mississippi-Louisiana State Line. The route runs along portions of U.S. Highway 61 and the entire of MS Hwy 1. The portion of the route from the Issaquena-Warren County Line to the Mississippi-Louisiana State Line has been designated as a National Scenic Byway and application for national designation for the remainder of the route is currently being reviewed by the Federal Highway Administration with approval expected later this year.
