PERS is requesting a total of \$20,000,000 in 2011 to fund our technology system upgrade. We are committed to pursuing the most economical avenues for adequate technological support of pension benefit administration. PERS' current programming language, Forte, is no longer a supported development platform. Enhancements to the Forte language, security patches and operating system are no longer available. In addition, the current programming and technical architecture does not support web-enabled functionality and is very difficult to integrate with third-party software and newer operating systems. PERS must continue to address the demands of our customers, as well as changes in technology, to effectively support the processing of pension benefits.

To date, PERS has engaged L. R. Wechsler, LTD., a technology consulting firm which specializes in pension fund technology solutions. We have issued vendor Request for Proposals for the new pension administration system. We estimate a three to five year project in the cost range of \$20,000,000 to \$25,000,000.
