**1. Comprehensive Mission Statement:**

Our role as a regulatory Commission is to oversee compliance with the Mississippi Code, Chapter 4, Title 73 and to form effective rules and regulations that protect the public while benefiting the Auction industry in Mississippi. We endeavor, through our actions, to continue a program of considerate but professional administration of duties and responsibilities mandated by the Mississippi Auctioneer License Act.

**2. Overview of the Agency 5- Year Strategic Plan**

The main priority is and will be to continue the licensing of all qualified persons who engage in the practice of Auctioneering.

The additional priorities will be as follows:

1. To protect the public by investigating any Auctioneer or Firm owner who has conducted him/herself in an unethical or unprofessional manner.
2. To renew 100% of the Auctioneers and Firm licenses upon expiration of their current license.
3. To establish reciprocity with all of the other license states to enable Mississippi Auctioneers to participate in the auction industry worldwide.

**3. Performance Effectiveness Objectives for Each Program from FY 2019 through FY 2023:**

FY 2019

Licensure and Regulation

1. Continue to effectively promote compliance with the license act.
2. License all qualified individuals.
3. Maintain awareness of the changes in the auction industry and inform the licensees of those changes.
4. Increase the amount of new licenses issued and renewed.
5. Encourage participation in the Continuing Education seminar sponsored by this agency.

Funding:

Requested special funds for FY 2019 are in the amount of \$118,297.00.

FY 2020 to FY 2023

1. Continue to license resident and non-resident Auctioneers and Firm owners.
2. Continue to establish reciprocity with all the license states to enable Mississippi Auctioneers to participate in the auction industry nationwide.
3. Continue to effectively execute the responsibilities of the Commission.
4. Continue to adhere to the plans set forth in the goals for FY 2018.

Funding:

Funds for FY 2020 to FY 2023 will be determined by anticipated increases and decreases in the cost of efficiently conducting Commission duties and business.

**4. Significant External Factors Which May Affect Performance:**

1. Number of Auctioneers and Firm owners renewing licenses.
2. Number of new licenses issued.
3. Number of applicants applying for licensure.
4. Number of applicants taking written examinations for licensure.
5. Number of valid complaints filed against licensed Auctioneers and Firm owners requiring investigation and/or hearing.
6. Changes in the standards of the practice of Auctioneering.

**5. Agency's Internal Management System Utilized to Evaluate Its' Performance:**

The Mississippi Auctioneers Commission is comprised of five licensed Auctioneers known as Commissioners. The Commission meets monthly to conduct necessary business. Special measures are taken to ensure that the needs of the Auctioneers, Firm owners, and the public are met and protected. A representative from the Attorney General's office is present at each meeting to offer assistance in dealing with each issue discussed by the Commission.
