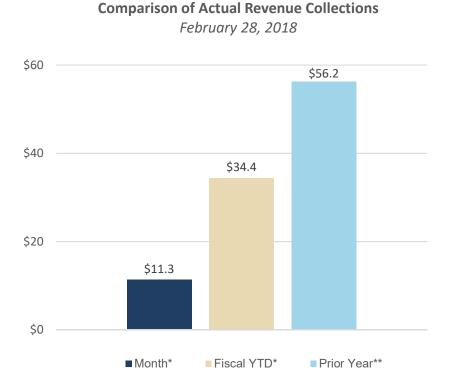

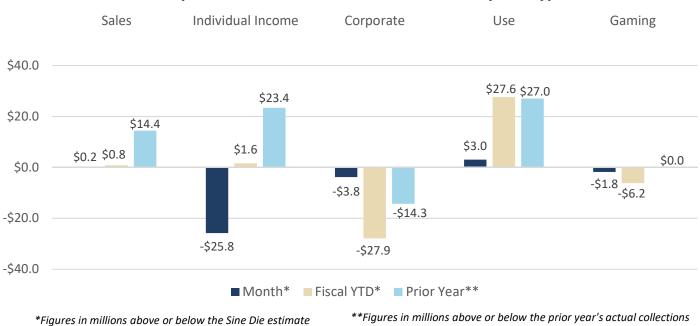

### <u>FY 2018</u>

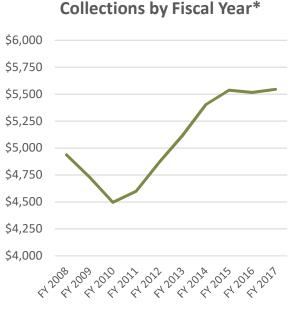
Total revenue collections for the month of February FY 2018 are \$11,309,741 or 3.65% above the sine die revenue estimate. Fiscal YTD revenue collections through February are \$34,441,369 or 1.05% above the sine die estimate. Fiscal YTD total revenue collections through February 2018 are \$56,153,415 or 1.73% above the prior year's collections.

The revenue collections for the month of February 2018 include an Attorney General settlement of \$32,190,378.



## **Comparison of Actual Revenue Collections by Tax Type**

The graph above compares the actual revenue collections to the sine die revenue estimate for each of the main tax revenue sources. The figures reflect the amount the actual collections for Sales, Individual, Corporate, Use and Gaming taxes were above or below the estimate for the month and fiscal year-to-date. The graph also compares fiscal year-to-date actual collections to prior year actual collections, as of February 28, 2018.

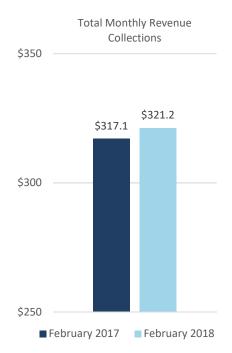
