



Total revenue collections for the month of January FY 2018 are \$1,150,205 or 0.28% above the sine die revenue estimate. Fiscal YTD revenue collections through January are \$23,131,627 or 0.78% above the sine die estimate. Fiscal YTD total revenue collections through January 2018 are \$52,060,914 or 1.78% above the prior year's collections.




Comparison of Actual Revenue Collections by Tax Type


