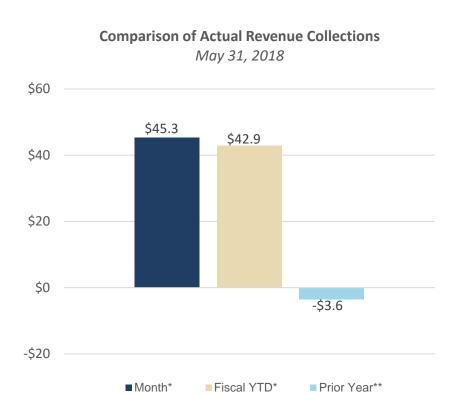

Total revenue collections for the month of May FY 2018 are \$45,309,420 or 10.25% above the sine die revenue estimate. Fiscal YTD revenue collections through May are \$42,894,548 or 0.87% above the sine die estimate. Fiscal YTD total revenue collections through May 2018 are \$3,621,581 or 0.07% below the prior year's collections.

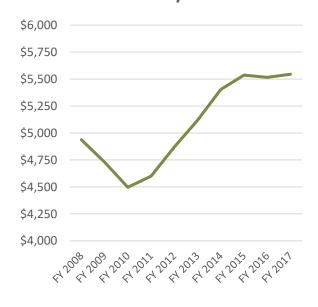
