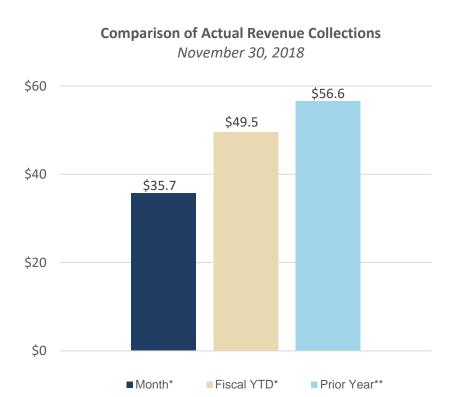

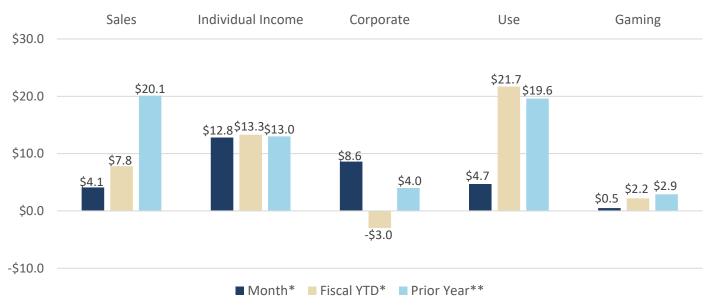
FY 2019

Total revenue collections for the month of November FY 2019 are \$35,725,672 or 9.30% above the sine die revenue estimate. Fiscal YTD revenue collections through November are \$49,464,586 or 2.37% above the sine die estimate. Fiscal YTD total revenue collections through November 2018 are \$56,626,788 or 2.72% above the prior year's collections.

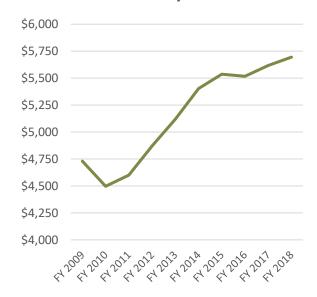

10-Year Historical Revenue Collections by Tax Type

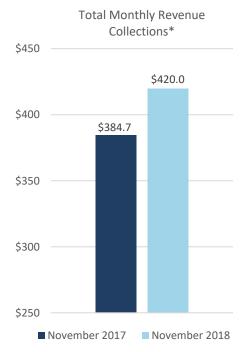
