


Total revenue collections for the month of April 2023 are \$35,148,318 or 3.48% above the sine die revenue estimate. Fiscal YTD revenue collections through April 2023 are \$637,014,667 or 11.20% above the sine die revenue estimate. Fiscal YTD total revenue collection through April 2023 are \$384,349,074 or 6.47% above the prior year's collections. The FY 2023 Sine Die Revenue Estimate is \$6,987,400,000.




