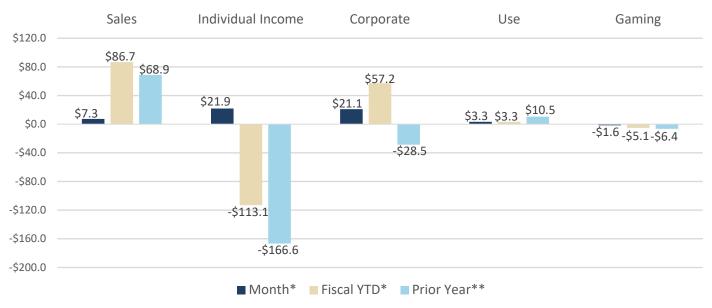
FY 2024

Total revenue collections for the month of March FY 2024 are \$87,074,990 or 16.93% above the sine die revenue estimate. Fiscal YTD revenue collections through March 2024 are \$178,944,639 or 3.51% above the sine die revenue estimate. Fiscal YTD total revenue collections through March 2024 are \$1,572,990 or 0.03% above the prior year's collections. The FY 2024 Sine Die Revenue Estimate is \$7,523,800,000.

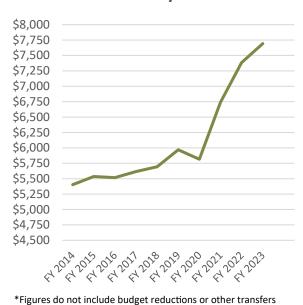

Individual income tax collections for the month of March were above the prior year by \$7.6M. Corporate income tax collections for the month of March were above the prior year by \$20.5M.
