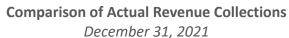

### FY 2022

Total revenue collections for the month of December FY 2022 are \$106,793,974 or 21.22% above the sine die revenue estimate. Fiscal YTD revenue collections through December 2021 are \$545,257,648 or 19.31% above the sine die estimate. Fiscal YTD total revenue collections through December 2021 are \$325,173,198 or 10.68% above the prior year's collections. The FY 2022 Sine Die Revenue Estimate is \$5,927,000,000.

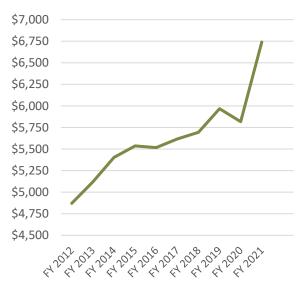
#### **Comparison of Actual Revenue Collections by Tax Type**

## 10-Year Historical Revenue Collections by Tax Type

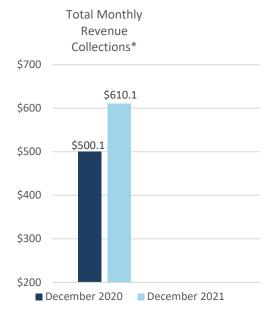

December FY 2022 General Fund collections were \$110,079,934 or 22.01% over December FY 2021 actual collections. Sales tax collections for the month of December were above the prior year by \$25.3M. Individual income tax collections for the month of December were below the prior year by \$4.3M. Corporate income tax collections for the month of December were above the prior year by \$83.7M.
