


Total revenue collections for the month of February 2023 are \$22,575,988 or 5.25% above the sine die revenue estimate. Fiscal YTD revenue collections through February 2023 are \$524,631,654 or 12.43% above the sine die revenue estimate. Fiscal YTD total revenue collection through 2023 February \$395,810,642 or 9.10% above the prior year's collections. The FY 2023 Sine Die Revenue Estimate is \$6,987,400,000.


Comparison of Actual Revenue Collections by Tax Type


