Total revenue collections for the month of April FY 2024 are \$6,869,739 or 0.65% above the sine die revenue estimate. Fiscal YTD revenue collections through April 2024 are \$185,814,378 or 3.01% above the sine die revenue estimate. Fiscal YTD total revenue collections through April 2024 are \$24,730,611 or 0.39% above the prior year's collections. The FY 2024 Sine Die Revenue Estimate is \$7,523,800,000.




Comparison of Actual Revenue Collections by Tax Type


