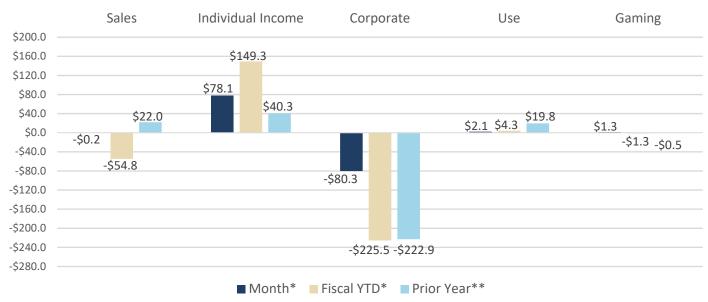

FY 2025

Total revenue collections for the month of April FY 2025 are -\$2,481,958 or -0.23% below the sine die revenue estimate. Fiscal YTD revenue collections through April 2025 are \$5,990,797 or 0.10% above the sine die revenue estimate. Fiscal YTD total revenue collections through April 2025 are -\$78,265,981 or -1.23% below the prior year's collections. The FY 2025 Sine Die Revenue Estimate is \$7,600,100,000.

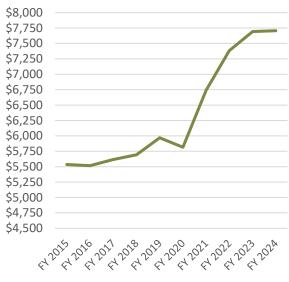

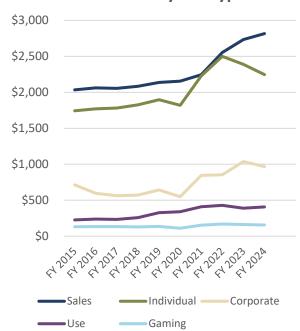

10-Year Historical Revenue Collections by Tax Type

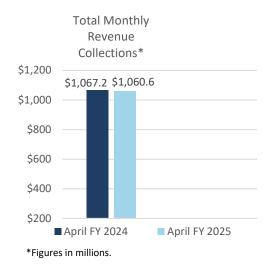
